

"FOR MY MOTHER'S DAY GIFT THIS YEAR, I DON'T WANT CANDY OR FLOWERS, I WANT AN END TO KILLING. WE WHO HAVE GIVEN LIFE MUST BE DEDICATED TO PRESERVING IT. PLEASE TALK PEACE."

This has been the message of Another Mother for Peace since 1967 when a handful of women gathered around a dining room table and resolved to speak out against the Vietnam War.

There is a lot of talk about peace in Washington these days now that we have withdrawn from the Iraq debacle and are scheduled to begin bringing troops home from Afghanistan in the coming year. But there is also talk of war: Though Iran has yet to produce a nuclear weapon, many are "beating the drums" for an unwarranted preemptive military strike against that country.

Resolutions in both the House (H.Res. 568) and Senate (S. Res. 380) assert that it is in our national interest to prevent Iran from acquiring even the capability to create a nuclear weapon. Further, the resolutions explicitly oppose any U.S. policy that would rely on "containment"--the approach used with the former Soviet Union--as a response to a nuclear weapons capable Iran.

Fortunately, there is a potent voice in the country, of which we are a part, that demands direct diplomacy in order to prevent another war and endless loss of life, along with the economic havoc that would result. Rep. Barbara Lee (D-CA) recently introduced a resolution (H.R. 4173) that directs the President to rescind the "no contact" rule and appoint a high-level representative or special envoy who would lead U.S. diplomatic efforts with Iran seeking to normalize relations between the two countries.

By going to OpenCongress.org, you can determine if your members of Congress have signed on as sponsors to any of these resolutions. Question their support of H.R. 568 and S. Res. 380 and ask them to co-sponsor H.R. 4173. You can write to them directly through the Open Congress website. Let Congress hear our opposition to yet more military action!

Congress also needs to know that we expect to see nearly one trillion dollars cut from the Pentagon budget over the next ten years: \$487 billion proposed by the President and \$500 billion as outlined by the Budget Control Act of 2011.

Under this act, when the congressional "super committee" failed to reach a deficit reduction agreement late last year, spending caps for all federal programs were supposed to go into effect, resulting in \$500 billion less for the military over the next decade.

Yet already that \$1 trillion in savings is being whittled away. For example, the President's budget for FY2013, released in February, does not comply with the Budget Control Act. The military's share has not been sufficiently reduced and certain "cuts" aren't really cuts at all. Furthermore, the limits set by the Budget Control Act could be by-passed if half the House or 60 members of the Senate agreed to waivers. You can bet that military contractors are already busy on Capitol Hill pleading with Congress to spare their projects.


Even if all Congress did was require the Pentagon to cut waste, the savings would be enough to meet the yearly budgets of the Departments of State, Interior, Commerce, Justice and Energy combined. In one year, the Pentagon loses more than \$100 billion from cost over-runs, shoddy bookkeeping, and the inability to keep track of money and inventory.

As mothers, and all of the members of AMP, we don't just want peace for ourselves, but for our children and children everywhere. In a more rosy economy, and in a time of peace, flowers and candy would be a delightful way to celebrate the day inspired by one woman's wish to end our sacrifice of loved ones to war. In the day when our government enacts peace as the priority, that rosy economy will be celebrated. For now, we send our most relevant and heartfelt Mother's Day greeting: *War is not healthy for children and other living things*.

Peace Homework




Rep. Gwen Moore (D-WI) has introduced legislation that shows what we could do if the Budget Control Act provisions are enforced and Pentagon spending is reined in. The RISE Out of Poverty Act (H.R. 3573) would rescind the worst features of the so-called "welfare reform" enacted under President Clinton and provide genuine pathways to ending child poverty. For example, the act permits states to extend benefits to youth up to the age of 21, mandates child care for recipients, requires states to provide for a family's basic economic needs, and allows recipients to seek high education. Tell your Representative to co-sponsor this bill and urge your Senators to introduce comparable legislation.





Out of every dollar we send to the IRS, a major portion goes to pay for war, past, present and future. Some calculate this misguided spending as 39 cents of every dollar (http://fcnl. org/assets/flyer/taxchart11.pdf), others say it's more like 47 cents (http://www. warresisters.org/node/1325). These figures are graphically presented in flyers published by the Friends Committee on National Legislation and War Resisters League.
